

MINUTES OF THE 21st ANNUAL GENERAL MEETING HELD ON TUESDAY 17 FEBRUARY 2009 AT NORMANDY VILLAGE HALL

1. The Chairman Peter Blakiston welcomed 49 Members to the meeting
2. The required number of Members (25) were therefore present to form a Quorum
3. Apologies had been received from 8 Members

AGM 2009 – Constitutional requirements

- 1.) The minutes for the 2008 AGM were adopted
- 2.) The Chairman submitted his 18th Annual Report, with a copy for each member present. Normandy Historians enjoyed a steady state of membership numbers (now well in excess of 100) and welcomed attendance of around 45 members at monthly meetings. Historically, socially and financially 2008 had been a grand year for the Society. He stressed that the Committee requires 2 new members and volunteers to fill these vacancies would be very welcome.
- 3.) The Auditor's statement for the 2007 Accounts was adopted. A query from the floor noted that the Auditor's statement covered the year ending 31 December 2007. The Chairman explained that the interval between December to the AGM in the following February was too short for an audit. The present adopted arrangement ensured a sound accounting base for continuity of audit
- 4.) The Treasurer John Squier had prepared a Financial Statement for 2008 with a copy for each member present. The Financial position at 31st December 2008 stands at Working Fund total £133.28. Publication Fund total £1,456.73. Total in cash £1,590.01. This Statement was adopted (subject to audit).
- 5.) The Editor reported that sales of "A History of Normandy Park in Surrey" remained slow but steady.
- 6.) The Membership Secretary reported that in 2008 the total membership was 133: Individual members -123 and Family members - 10.
- 7.) The Calendar of Events and Speakers for 2009 was presented to members.



- 8.) The retiring Executive Committee was re-elected

There are therefore two vacancies.
- 9.) Jim Chisnall was appointed as Auditor to the Society.
- 10.) Subscription rates would remain unchanged for 2009 –
Individual members £3, Family members £7.50.
Consideration was given to buying a white screen to show
slides, but the majority of members were happy with the present
practice of showing them straight on to the wall.
The Social evening arrangements used in 2008 would continue
along the same lines in December this year.

Anniversary this year.
3. The 2010 AGM will take place on Tuesday 16th February.
The Chairman welcomed Isobel Willis & Margaret Saunders, our guest

CHAIRMAN'S REPORT TO THE TWENTY-SECOND ANNUAL GENERAL MEETING

Tonight gives me the very great pleasure to deliver my Nineteenth Annual Report to members. I trust that, like me, all members will agree that the passing year has been a rewarding one for the Society. Our membership count is well over the magic number of 100 and attendance levels at our Open Meetings are consistently in the 40 to 50s region. Also, we enjoy a stable financial position.

The guest speakers and the range of topics engaged during the year continued at the same high quality as in previous years, but it is evident that the call on our financial resources is noting the increase in the fees asked by speakers. That shift might have to be recognised and our finances re-examined in future.

It is worth noting and updating some achievements from previous years:

1. Sales of the Normandy Park book have far exceeded the halfway stage, which is quite rewarding
2. Steady sales of the Normandy Book CD continue to aid the income sources of our finances.
3. The transcribing of newspaper cuttings "Normandy in the Press" is approaching finality.
4. The updating of "All properties in Normandy" continues and is attracting the attention of other local history societies, also that of The History Centre, Woking
5. The reduction in Committee meetings started in 2009 is working successfully and will be continued into 2010.
6. The email address base of members continues to increase.

During 2009 we:

7. Discontinued providing articles for the Normandy and Worplesdon GU3 Directories due to editorial changes and discontinuation of one group of directory publishers.
8. Strengthened our resolve to complete research into the family history of The Fallen of two World Wars, more so since an increase in interest through our website www.normandyhistorians.co.uk.
9. Added digests about persons and beneficiaries to our website from Wyke Wills of Surrey held at The History Centre, Woking
10. Also added a comprehensive list of Friends (Quakers), buried at Fairlands Farm to our web-site that will assist family history researchers.



11. Made a start on indexing our collection of scrapbooks. This index when added to the website, alongside the present “Normandy in the Press” indexing, will be an invaluable aid to researchers.
12. Said farewell to Mark Bond, who had to retire from the committee to concentrate on his IT work at the Guildford College of Law. Mark had given valuable technical aid to the society
13. Welcomed Derek Francis and Neville Wheatley to the committee as co-opted members.

The continuing success of Normandy Historians is due in no small way to your Executive Committee and the individual contributions made by a small number of members. Their continuing hard work and loyal support is much appreciated by me, but perhaps a reference to some will not come amiss:

14. The indefatigable Maidie Chattaway has helped tremendously (with Diana Marchant our secretary) in transcribing the old records of St Mark’s Church, the manuscript notes from Sally Sherwood’s researches and more recently the commencement of indexing the collection of scrapbooks, not forgetting her services at the refreshments counter of course.
15. The refreshment helpers: Heather Edgington, the late Bill Beale and again the ever helpful Diana Marchant.
16. Alan Norris, Eira and James Nursaw and Steve Cranstone, have between them and (let it be said), after many years have almost finished transcribing Peter Trevaskis’s manuscript extracts for “Normandy in the Press”.
17. More recently we welcomed Ros Clements to the ranks in transcribing the Friends Burial Records.
18. John Hillier, who has represented us in maintaining good relations with the Surrey Heath Museum Action Group and their efforts to establish a permanent Culture and Heritage Centre at Camberley.
19. Finally “Ashley” Hoare, our technical wizard, designer and manager of our very successful website.

On Sunday the 4th July 2000, at Wyke School, the society launched its book **“A Century of Normandy in Surrey”** as its contribution to the Village celebrations for The Millennium.

The initial print run of 740 books, all of which were sold at £7.50 each in the first year, was made financially possible by Awards from Central and Parish Funds. The second print run was sold by the end of 2003 also at £7.50 each by using profit generated from original sales. Further print runs were unjustified by cost and anticipated limited sales. “The Book” continues to be published in CD format.
