MINUTES OF THE 31st ANNUAL GENERAL MEETING HELD ON TUESDAY 19th FEBRUARY 2019 AT NORMANDY VILLAGE HALL

1. The Chairman, Christopher Pettitt, welcomed 32 members to the meeting.
2. Apologies for absence were received from Peter Southwell.
3. Quorum: The committee proposed that the quorum for the AGM should be 15 members, reduced from the previous 25 members, due to a reduction in the membership numbers from earlier years. The meeting accepted this change with no objections.
4. The Minutes of the 2018 Annual General Meeting (included in the Annual Report papers) were adopted.
5. The Annual Report and Accounts was previously circulated to Members (by e-mail or post). The Report was taken as read and was adopted by Members with no questions.

The Accounts showed a total account balance at end of 2018 of £2115 (balance at end of 2017 of £2151). The Accounts were adopted with no questions.

6. The committee proposed the Annual Subscription rate for 2019 be unchanged at £5 per person. This was accepted by Members.
7. Election of Executive Committee.

The committee proposed that the current Officers be re-elected:

Christopher Pettitt informed members that the position of Secretary was still vacant following the resignation and passing away of the late Sandra Grainger, the previous secretary. No nominations for Secretary were proposed. The Secretary's responsibilities have been undertaken by other committee members on an interim basis.

No matters were raised by the members present.

The Calendar of Events for 2019 was circulated with the AGM Report.

COMMITTEE REPORT FOR 2019

The Historians has enjoyed another successful year with a full programme of speakers and other events.

In February a memorial social event, organised by family members, was held at the Hogs Back Hotel for Sandra and Brian Grainger who had made a substantial contribution to the success of the Historians over many years. The attendance of large numbers of friends and family, including several Historians, was a reflection of the very high regard in which Sandra and Brian are held.

Our AGM in February was followed by a talk by Steve Cranstone on Sidney Sime, a local artist who lived in Worplesdon. A Historians visit to the gallery at Worplesdon Memorial Hall, to view Sidney's fantastical and satirical work, followed soon afterwards.

In March Paul Backhouse gave a talk on Alan Turing and his substantial connections to Guildford. In April Dr Becky Peacock gave a talk on the role of women on the railways 1850 to 1945 which highlighted the discrimination women faced in a male dominated industry.

In May Mel Rees gave an entertaining talk on the Hogs Back Brewery which also enabled Historians to sample the brews they current offer.

In June the Historians main outing for 2019 was a visit to the Foreign Office in Whitehall. The Foreign Office was built at the height of Empire and the grand architecture reflected this. We were shown round by Tara Finn, an F.O. official.

In September committee member Alan Norris spoke on Normandy – a village history, at what was probably our best attended meeting of the year. In October Mary Clayton gave a talk on Charlotte Walker – an 18th century prostitute and thief, which highlighted the enormous contribution that digitising old legal records has made to telling the stories of individuals who come into contact with the law. In November Eileen Wicks demonstrated her in depth knowledge of The National Archives in a talk which described the incredible range and depth of material held by the government on our behalf. As usual the year concluded in December with our Christmas Social.

Research by the Historians was limited in 2019 as sterling work in previous years has left very few areas where new research could be undertaken.

Very unfortunately our Chairman Chris Pettitt suffered serious ill health during the year which prevented him chairing many meetings, and has led him to stand down as Chairman at the end of the year. Chris was a characterful chairman who will be much missed, and we send him our very best wishes.

The vital role of Secretary was not formally filled during 2019 however committee member Alan Norris stepped in and undertook most of the duties of this role. Alan located and arranged nearly all the speakers for the Historians 2019 and 2020 programme of talks, and the Historians owe him a large debt in this regard.
